

Hope Scholarship Subcommittee on Appeals Minutes

The meeting of the Hope Scholarship Subcommittee on Appeal was called to order by Anthony Woods, Chair, on Friday, February 24, 2023, at 3:04 pm after determination that a quorum of members was present through a silent roll call. Subcommittee members attending the meeting: Jonathan “Zak” Ritchie, and Charlie Russell. One member of the public attended the meeting.

Approval of the Minutes

The Chair indicated the first item on the agenda was the approval of the minutes of the February 3, 2023 meeting, which were distributed to the members prior to the meeting. The Chair asked if there were any additions or corrections to the minutes and none were noted. A motion to approve the minutes was made by Mr. Russell and seconded by Mr. Ritchie. The Chair asked for discussion and there was none. The Chair polled the members and the motion to approve the minutes was adopted.

Mr. Ritchie seconded the motion. No discussion was heard. The chair polled the members, and the motion was approved to move into Executive Session.

The Subcommittee entered Executive Session at 3:07 P.M. All non-board members except for board staff were asked to vacate the virtual meeting and were asked to wait in the TEAMS lobby.

The board returned to order at 3:39 P.M. All attendees waiting in the TEAMS lobby were readmitted to the virtual meeting. The Chair issued a reminder that no action was taken during the Executive Session.
